



## PRE-REGISTRATION & SCREENING PROCEDURES 2017-2018 School Year

Applications will be accepted beginning on April 10, 2017, from 8:00am to 12:00pm daily, at Silver Strand School, 1350 Leyte Road, Coronado. Applications are available in the school office and should be turned in with all required documents as soon as possible. Incomplete packets will not be accepted. After class placement has occurred and the class is full, registration will remain open and applicants will be placed on a waiting list and called when space becomes available.

### State Preschool Program

The Coronado Unified School District is pleased to offer a State Preschool Program at Silver Strand School, which services up to 24 students and is based on family size and family income. The half-day (3½ hours per day) services of the Silver Strand State Preschool are available to Coronado resident families who are at or under the income ceilings established by the California State Department of Education.

Silver Strand State Preschool fulfills the original vision for Coronado Unified School District (CUSD) to provide a complete education continuum as a lifelong foundation for our community's children. The curriculum integrates with existing CUSD curricula and combines it with learning designed to enhance cognitive development and establish the basic building blocks for a successful education for 21st century learners.

### State Preschool Qualifications

1. **Age:** Child must be between 3 and 4 years (not eligible for Transitional Kindergarten or Traditional Kindergarten) on the first day of school. Children must be 3 to 4 years of age on or before September 1, 2017.
2. **Immunization:** Child must have 3-Polio, 4-DPT, 1-HIB, 3-HepB, 1 Varicella, and 1 MMR (given after 1st birthday)
3. **Residency:** Child and family must be Coronado Unified School District residents.
4. **Income Eligible:** Family income must fall within the State guidelines for low income.
5. **Priority:** Given to children who will attend Kindergarten the following year.
6. **Toilet Use:** All children are required to be potty trained before enrollment in the program.

### State Preschool Application Process

Children meeting the program qualifications may apply for the program by presenting the required documentation to the Silver Strand School office. To apply for the program you must provide the following:

1. Child's birth or baptismal certificate (Original or certified copy)
2. Birth or baptismal certificate for all dependent children (Military Page 2 is also accepted)
3. Child's immunization record (Signed/stamped by a physician or other medical professional)
4. Family's **current** proof of income for all employed parents/guardians:
  - Military LES statement
  - Pay stub(s) (Equivalent to 1 month's income)
  - AFDC (Call your social worker for a current copy of your Notice of Action)
  - If Self-Employed, Current profit/loss statement
  - Any Disability, Unemployment or Social Security Benefits
5. 2-Proofs of residence (See back of Affidavit Verification of Residency for acceptable documents)
6. Completed and signed application packet available in the Silver Strand School office.  
**Incomplete packets will not be accepted.**
7. **When notified of admission to Silver Strand State Preschool, formal registration will follow.**
