# Silver Strand Elementary School Title I School-Level Parental Involvement Policy

Silver Strand Elementary School has developed a written Title I parental involvement policy with input from Title I parents that was received via both parent survey and meeting. It has distributed the policy to parents of Title I students at its annual fall meetings. ## Involvement of Parents in the Title I Program

Silver Strand Elementary School does the following:

- 1. Convenes annual meetings to inform parents of Title I students of Title I requirements and their rights to be involved in the Title I program. Background re: Title I funding, essential elements of the Title I academic assistance program as it applies to our school, family/school compact, and other pertinent information is provided at this meeting.
- 2. Offers a flexible number of meetings by offering opportunities to meet both during the school day and after school hours.
- 3. Involves parents of Title I students in an organized, ongoing, and timely way, in the planning, review, and improvement of its Title I programs and the Title I parental involvement policy. This review takes place by means of input from the Title I Parent Advisory Committee.
- 4. Provides parents of Title I students with timely information about Title I programs via annual meetings.
- 5. Provides parents of Title I students with an explanation of the curriculum, assessments, and proficiency levels students are expected to meet. This information is part of the annual meetings. This information is also made available to parents of Title I students during annual parent/teacher conferences as well as Open House night in the spring. A policy review is also part of regularly scheduled Title 1 Parent Advisory Committee and School Site Council meetings.
- 6. Provides parents of Title I students, if requested, with opportunities for regular meetings to participate in decisions relating to the education of their children via ongoing communication with site Reading Specialist and both regularly scheduled and as requested parent/teacher conferences.

#### **School-Parent Compact**
